RESOLUTION NO. 2012-MPO-006

Authorizes the DMD to enter into an agreement with Caliper Corporation in an amount not to exceed \$8,000 (\$6,400.00 federal, \$1,600.00 local) to provide technical assistance and training to the Indianapolis MPO staff in the

GISDK computer scripting language that serves as the language for the Indianapolis travel demand model.

RESOLUTION NO. 2012-MPO-007

Authorizes the DMD to negotiate and enter into an agreement with the firm, Apparatus, Inc., to provide technical assistance in upgrading and redesigning the MPO's public website, utilizing federal transportation planning funds received by the MPO, with local matching funds provided by the MPO and its planning partners for a total contract amount of \$15,000.00 (\$12,000.00 federal, \$3,000.00 local).

RESOLUTION NO. 2012-MPO-008

Authorizes the DMD to negotiate and enter into an agreement with Cambridge Systematics, Inc. in an amount not to exceed \$30,000 (\$24,000.00 federal, \$6,000.00 local) to provide on-call planning services pertinent to the implementation of the most recent motor vehicle emissions model provided by the U.S. Environmental Protection Administration, during the process of coordinating State Implementation Plan development with the Indiana Department of Environmental Management and any updates or amendments to the Indianapolis MPO's Long-Range Transportation Plan.
