PROPOSAL NO. 188, 2010 - appropriates \$3,600,000 in the 2010 Budget of the Department of Metropolitan Development (Redevelopment General Fund) to fund the implementation of strategies designed to accelerate economic growth in the Downtown Indianapolis Tech Park district.

PROPOSAL NO. 189, 2010 - appropriates \$5,300,000 in the 2010 Budget of the Department of Metropolitan Development (Redevelopment General Fund) to fund the implementation of marketing strategies designed to increase leisure travel to Indianapolis to Indianapolis and to increase the quality and quantity of conventions in the city, financed by a local grant.

PROPOSAL NO. 10, 2010 reappoints Alan E. Retherford to the Metropolitan Board of Zoning Appeals, Division III.
