There will be a meeting of the Public Works Committee of the City-County Council on **Thursday, August 5, 2010 at 5:30 p.m. in Room 260** of the City-County Building. It is anticipated that the following items may be considered by the Committee:

PROPOSAL NO. 216, 2010 - reappoints Reginald Mallamo to the Air Pollution Control Board

PROPOSAL NO. 217, 2010 - appropriates \$9,822,167 in the 2010 Budget of the Department of Public Works (Federal Stimulus Grants Fund) for a new neighborhood-scale energy retrofit program for the City's Near Eastside Neighborhood, a residential loan program for energy improvement measures, and a subgrant to the City of Lafayette for residential energy retrofits, financed by an Energy Retrofit Ramp-up grant from the U.S. Department of Energy

PROPOSAL NO. 218, 2010 - authorizes parking restrictions for Eagle Creek Parkway north of 46th Street and Falcon Talon Lane east of Eagle Creek Parkway (District 6)

PROPOSAL NO. 219, 2010 - authorizes parking restrictions on the south side of 46th Street from College to Keystone Avenue (District 9)

PROPOSAL NO. 220, 2010 - authorizes the removal of parking restrictions on the west side of Sunset Avenue from Blue Ridge Road to Lake Road (District 8)
