There will be a meeting of the Rules and Public Policy Committee of the City-County Council on **Monday, August 30, 2010, at 5:30 p.m. in Room 260** of the City-County Building. It is anticipated that the following items may be considered by the Committee:

PROPOSAL NO. 225, 2010 - amends the Code requiring the Purchasing Division to adopt rules to give a preference to Indiana businesses pursuant to IC 5-22-15-20 and to companies participating in the Indiana Business Plan

PROPOSAL NO. 228, 2010 - amends the Revised Code of the Consolidated City and County to correct certain obsolete references to the Indiana Code

PROPOSAL NO. 229, 2010 - approves and authorizes the execution of a concession agreement to grant a concessionaire the right to operate, maintain and improve the metered parking system of the City of Indianapolis and amends the Code to provide for, among other things, new metered parking zones, hours of operation and rates for the metered parking system in accordance with the provisions set forth in such concession agreement
