There will be a meeting of the Public Safety Committee of the City-County Council on **Wednesday, March 23, 2011, at 5:30 p.m. in Room 260**. It is anticipated that the following items may be considered by the Committee:

PROPOSAL NO. 299, 2010 - amends the Code to add a new Chapter 986 to establish standards for security companies doing business in Marion County, including licensing by the Office of Finance and Management to include criminal background checks and experience requirements

PROPOSAL NO. 82, 2011 - amends the Code by adopting a new Chapter 941 requiring permits for police escorts for professional sports teams and a new Division 7 in Article III of Chapter 135 to create the Law Enforcement Equipment and Training Fund

PROPOSAL NO. 83, 2011 - amends Chapter 279 of the Code dealing with police reserves

PROPOSAL NO. 84, 2011 - amends certain provisions of the current merit system respecting the Indianapolis Metropolitan Police Department and the Indianapolis Fire Department

PROPOSAL NO. 86, 2011 - amends the Code to eliminate the metropolitan emergency communications agency and board, to reassign certain powers, duties and responsibilities thereof to the department of public safety and the Marion County Sheriff's Department, to create two new divisions of the department of public safety, and to make corresponding technical amendments

PROPOSAL NO. 98, 2011 - corrects the term ending date for Sam Nunn as an appointee to the Indianapolis-Marion County Forensic Board
