PROPOSAL NO. 137, 2011 - authorizes an all-way stop at the intersection of Grant Avenue and Minnesota Street (District 20)

PROPOSAL NO. 138, 2011 - authorizes an all-way stop at the intersection of Audubon Road and Bonna Avenue (District 21)

PROPOSAL NO. 139, 2011 - authorizes a change in one-way traffic flow on a portion of Layman Avenue to two-way traffic (District 21)

PROPOSAL NO. 140, 2011 - authorizes a multi-way stop at the intersection of Groff Avenue and Wilcox Street (District 14)

PROPOSAL NO. 142, 2011 - approves the renegotiated contract with Indianapolis Power and Light Company to provide energy for public lighting, including street lighting and traffic signals owned by the city, and authorizes the director of the department of public works to execute such contract
