PROPOSAL NO. 173, 2011 - authorizes a relocation of the parking meter zone on Maryland Street between Missouri Street and Capitol Avenue and deletion of the parking restrictions on Maryland Street between West Street and Missouri Street (District 15)

PROPOSAL NO. 61, 2011- amends the Code to make changes to the Industrial Pretreatment Program as required and approved by the EPA and IDEM to reflect the transfer of the water and wastewater systems to the Department of Public Utilities and CWA Authority, Inc. of Citizens
