PROPOSAL NO. 286, 2011 - transfers and appropriates a total of \$8,124,724 in the 2011 Budget of the Office of the Mayor, Office of Finance and Management, Office of Corporation Counsel, Marion County Treasurer, Marion County Surveyor and Information Services Agency (Debt Service, Federal Grants, Consolidated County, County General, Endorsement Fee, Enhanced Access and Perpetuation Funds) for various uses, funded by new revenues not previously appropriated, reductions of appropriations, and fund balances

PROPOSAL NO. 287, 2011 - determines the need to lease approximately 8,642 square feet of space at the Indiana State Fairgrounds, Discovery Hall, for use by the Marion County Cooperative Extension Services
