There will be a meeting of the Rules and Public Policy Committee of the City-County Council on **Tuesday, November 29, 2011 at 5:30 p.m.** in **Room 260** of the City-County Building. It is anticipated that the following items may be considered by the Committee:

PROPOSAL NO. 315, 2011 - censures Councillor Ryan Vaughn and removes him as President of the Council for his unilateral and unauthorized use of Council funds to contract with David Brooks to redraw precinct boundaries

PROPOSAL NO. 316, 2011 - requires that the president of the Council rescind/cancel that certain contract for the redrawing of precinct boundaries and of Council election districts and to encumber the remaining unspent and remaining funds on said contract in the Council budget

PROPOSAL NO. 317, 2011 - provides that the committee on committees review and determine its approval or rejection of any contract for services or other proposed expenditures in excess of five hundred dollars (\$500) prior to the execution of any such contract or incurrence of any such expenditure

PROPOSAL NO. 338, 2011 - establishes the Office of Education Innovation and creates an education tax credit and a charter school incubator program
