There will be a meeting of the Rules and Public Policy Committee of the City-County Council on **Tuesday, June 12, 2012 at 5:30 p.m.** in the **Public Assembly Room** of the City-County Building. It is anticipated that the following items may be considered by the Committee:

PROPOSAL NO. 179, 2012 - amends Chapter 901 of the Code by making it a condition of licensure that a hotel not be party to any agreement that prevents the hotel from hiring employees of a hotel cleaning service

PROPOSAL NO. 209, 2012 - establishes the Marion County Property Tax Amnesty Program pursuant to I.C. 6-1.1-37-10.1

PROPOSAL NO. 210, 2012 - encourages the Treasurer and Auditor to implement an optional pre-tax sale payment plan

PROPOSAL NO. 211, 2012 - amends the Code to allow for regulation and oversight of flea market sales in the city and county

PROPOSAL NO. 212, 2012 - supports and encourages the right of janitors to a livable wage, health insurance, job security, safe working conditions, and a union contract

PROPOSAL NO. 213, 2012 - establishes Domestic Partnership and provides equitable benefits for Consolidated City and County employees who are in a domestic partnership

PROPOSAL NO. 221, 2012 - adopts policies that comply with House Enrolled Act 1005 concerning nepotism and contracting with relatives
