PROPOSAL NO. 233, 2012 - authorizes the issuance of economic development revenue bonds not to exceed \$10,000,000 to Synergy North Oaks, LLC, for a portion of the cost of acquisition, renovation and equipping of an existing 398-unit multifamily rental housing facility located at 5018

PROPOSAL NO. 261, 2012 - final authorization for the issuance of multifamily housing revenue bonds not to exceed \$23,000,000 to Covered Bridge, Indiana, LLC, for the acquisition, renovation and equipping of a 252-unit multifamily housing facility with related recreational facilities and parking area located at 4909 Covered Bridge Road (Covered Bridge Apartments Project) (District 1)

PROPOSAL NO. 262, 2012 - final authorization for the issuance of multifamily housing revenue bonds not to exceed \$18,000,000 to Meadowlark Indiana, LLC, for the acquisition, renovation and equipping of a 360-unit multifamily housing facility with related recreational facilities and parking area located at 9350 E. 43rd Street (Meadowlark Apartments Project) (District 12)
