Re: Meeting Notice

There will be a meeting of the Public Works Committee of the City-County Council on **Thursday, October 31, 2013 at 5:30 p.m. in Room 260** of the City-County Building. It is anticipated that the following items may be considered by the Committee:

PROPOSAL NO. 259, 2013 - authorizes parking restrictions on East Street and Virginia Avenue near South Street (District 19)

PROPOSAL NO. 320, 2013 - appropriates \$126,593.72 in the 2013 Budget of the Department of Public Works (Federal Stimulus Funds) from a prior year Department of Energy grant award to implement energy retrofit programs in the Near Eastside Neighborhood

PROPOSAL NO. 321, 2013 - appropriates \$27,011 in the 2013 Budget of the Department of Public Works (State of Indiana Grants Fund) from prior year Indiana Department of Natural Resource Grants to perform a tree inventory in Warren and Lawrence Townships

PROPOSAL NO. 322, 2013 - authorizes an increase in the speed limit on South County Line Road between Meridian and Shelby Streets (District 23)

PROPOSAL NO. 323, 2013 - authorizes weight restrictions on Legrande Avenue and Draper and Van Buren Streets (District 20)

PROPOSAL NO. 324, 2013 - authorizes one-way restrictions on Alley 4550 East, from Michigan to New York Street (District 21)

PROPOSAL NO. 325, 2013 - authorizes intersection controls at Mendenhall and Milhouse Roads (District 22)

PROPOSAL NO. 326, 2013 - authorizes a change in parking restrictions on Cornell Avenue from 66th Street to Spur Lane (District 3)

PROPOSAL NO. 327, 2013 - authorizes a speed limit reduction in the Country Club Pines subdivision (District 6)
