There will be a meeting of the Public Safety and Criminal Justice Committee of the City-County Council on **Wednesday, December 4, 2013, at 5:30 p.m. in Room 260** of the City County Building. It is anticipated that the following items may be considered by the Committee:

PROPOSAL NO. 343, 2013 - approves a transfer of \$100,171 in the 2013 Budget of the Marion County Sheriff's Office (County General Fund) to cover deputy salaries and overtime costs for the remainder of 2013

PROPOSAL NO. 344, 2013 - approves a transfer of \$115,000 in the 2013 Budget of the Department of Public Safety, Public Safety Communications ((Public Safety Communications General Fund) for computer, network and CAD equipment

PROPOSAL NO. 345, 2013 - approves certain public purpose grants totaling \$390,000 from the Drug Free Community Fund

PROPOSAL NO. 364, 2013 - amends the Code regarding fire safety requirements for battery-powered smoke detectors
