PROPOSAL NO. 349, 2012 - approves an amendment to the declaratory resolution and redevelopment plan for the Fall Creek/Citizens Consolidated Redevelopment Area

PROPOSAL NO. 253, 2013 - approves a resolution and economic development plan establishing the Madison Avenue Economic Development Area

PROPOSAL NO. 366, 2013 - authorizes the final bond issuance for Flaherty and Collins Properties, Inc. (MSA North) in an amount not to exceed \$23,000,000 for the construction, acquisition, renovation and equipping of a new 28-story mixed-use development facility, consisting of approximately 300 luxury apartments, 43,000 square feet of retail space and a 550-space parking facility located on a downtown square block bounded on the south by East Market Street, on the west by North Alabama Street, on the north by East Wabash Street, and on the east by North New Jersey Street (District 15)
