PROPOSAL NO. 88, 2014 - authorizes intersection controls on Clifford Drive and Chesterhill Lane (District 21)

PROPOSAL NO. 89, 2014 - authorizes intersection controls at Broadway Street and Laverock Road (District 3)

PROPOSAL NO. 90, 2014 - approves an additional appropriation of \$8,000,000 in the 2014 Budget of the Department of Public Works (Consolidated County Fund, Rebuild Indy subfund) for road and street repair and resurfacing projects
