There will be a meeting of the Public Safety and Criminal Justice Committee of the City-County Council on **Wednesday, August 20, 2014, at 5:30 p.m. in Room 260** of the City-County Building. It is anticipated that the following items may be considered by the Committee:

PROPOSAL NO. 229, 2014 - approves an appropriation of \$1,500,000 in the 2014 Budget of the City-County Council (RebuildIndy Sub-Fund) for contractual expenditures related to public safety and neighborhood stabilization efforts

PROPOSAL NO. 245, 2014 - approves an additional appropriation of \$95,000 in the 2014 Budget of the Marion County Community Corrections (County General and County Cumulative Capital Funds) to fund four additional customer service managers' salaries, benefits and other associated costs and two vehicles for home visits

PROPOSAL NO. 246, 2014 - approves the adoption of the Division of State Court Administration's statewide court case management system called Odyssey

PROPOSAL NO. 247, 2014 - approves the execution of an amendment to add the Roth option to the deferred compensation plan of the City of Indianapolis and Marion County for its sworn firefighters

PROPOSAL NO. 248, 2014 - proposes an ordinance of the Marion County Income Tax Council to rescind the local homestead credit and increase the income tax rate for public safety, effective January 1, 2015, and to cast the vote of the City-County Council on such ordinance
