PROPOSAL NO. 215, 2014 - amends Chapter 581 of the code to add as a discriminatory practice the denial of equal opportunities based on source of income

PROPOSAL NO. 274, 2014 - amends the Code to limit signage allowed on the floor of the council chamber

PROPOSAL NO. 276, 2014 - determines that the funds are not appropriated or otherwise available to support continuation of performance of certain contracts and cancels those contracts

PROPOSAL NO. 291, 2014 - amends the Code to add certain protections for the homeless

PROPOSAL NO. 366, 2014 - reappoints Barbara Howard to the Alcoholic Beverage Board of Marion County

PROPOSAL NO. 367, 2014 - amends the Code to create a new non-reverting Indianapolis pre-k fund; add the community affairs and education committee as a standing committee of the council; repeal the council rule on approval of charter schools; replace such rule with a new one giving the community affairs and education committee oversight of the Indianapolis pre-k program; and establish the Indianapolis pre-k program
