PROPOSAL NO. 289, 2014 - thanks Indianapolis Power and Light Company for committing to a plan to stop burning coal in Marion County by 2016 and reducing toxic emissions at the Harding Street plant and encouraging investment in greater amounts of clean, renewable energy

PROPOSAL NO. 44, 2015 – approves the United Way of Central Indiana, Inc. as the program administrator for the Indianapolis pre-k program

PROPOSAL NO. 45, 2015 – amends Chapter 135, Article VII of the Code regarding the fiscal stability fund

PROPOSAL NO. 46, 2015 - appropriates \$4,200,000 in the 2015 Budget of the Office of the Mayor (Consolidated County Fund) to cover costs related to the establishment of the Early Childhood Education and Indianapolis Pre-kindergarten programs
