There will be a meeting of the Public Safety and Criminal Justice Committee of the City-County Council on **Wednesday, March 11, 2015, at 5:30 p.m. in Room 260** of the City-County Building. It is anticipated that the following items may be considered by the Committee:

PROPOSAL NO. 229, 2014 - approves an appropriation of \$1,500,000 in the 2014 Budget of the City-County Council (RebuildIndy Sub-Fund) for contractual expenditures related to public safety and neighborhood stabilization efforts

PROPOSAL NO. 47, 2015 - appropriates \$4,700,000 in the 2015 Budget of the Department of Public Safety, Indianapolis Police Department (IMPD General and Public Safety Income Tax Funds) for various public safety initiatives

PROPOSAL NO. 66, 2015 - reappoints Alfarena Ballew to the Domestic Violence Fatality Review Team

PROPOSAL NO. 67, 2015 - appoints Elizabeth Eglon to the Domestic Violence Fatality Review Team

PROPOSAL NO. 68, 2015 - reappoints Caroline Fisher to the Domestic Violence Fatality Review Team

PROPOSAL NO. 69, 2015 - appoints Kelly McBride to the Domestic Violence Fatality Review Team

PROPOSAL NO. 70, 2015 - reappoints Tracy McQueen to the Domestic Violence Fatality Review Team

PROPOSAL NO. 71, 2015 - corrects the terms of certain members appointed to the Domestic Violence Fatality Review Team

PROPOSAL NO. 72, 2015 - approves an additional appropriation of \$562,595 in the 2015 Budget of the Department of Public Safety (Consolidated County General Fund) for the funding of an Engagement Center located at 742 E. Market Street

PROPOSAL NO. 73, 2015 - approves an additional appropriation of \$908,150 in the 2015 Budget of the Marion County Prosecutor's Office (County General Fund) for the annual funding of nine additional deputy prosecutor positions and six additional support staff

PROPOSAL NO. 74, 2015 - amends Chapter 135 of the Code to create a new non-reverting police recruiting fund

There will be a meeting of the Public Works Committee of the City-County Council on **Thursday, March 12, 2015 at 5:30 p.m. in Room 260** of the City-County Building. It is anticipated that the following items may be considered by the Committee:

PROPOSAL NO. 75, 2015 - approves intersection controls for Aylesworth Court, Pleasant Garden Lane and Heartland Boulevard (District 22)

PROPOSAL NO. 76, 2015 - authorizes parking restrictions on College Avenue near North and Eleventh Streets (District 9)

PROPOSAL NO. 77, 2015 - authorizes parking restrictions on Park Avenue from Michigan Street to Massachusetts Avenue (District 9)

PROPOSAL NO. 78, 2015 - authorizes intersection controls in the Valley Ridge at Heartland Crossing subdivision (District 22)

PROPOSAL NO. 79, 2015 - authorizes intersection controls at Lee and Miller Streets and parking restrictions on Richland Street (District 19)

PROPOSAL NO. 80, 2015 - authorizes intersection controls and one-way restrictions on Alabama, Delaware and Pearl Streets (Districts 15 and 19)

PROPOSAL NO. 81, 2015 - authorizes intersection controls in the Cumberland Lakes subdivision (District 18)

PROPOSAL NO. 82, 2015 - authorizes intersection controls in the Cherry Lake subdivision (District 18)

PROPOSAL NO. 83, 2015 - authorizes a speed limit reduction in the Holly Hills subdivision (District 24)

PROPOSAL NO. 84, 2015 - approves an additional appropriation of \$550,000 in the 2015 Budget of the Department of Public Works (Federal Grant Funds) to cover program costs for Air Quality education and temporary projects and programs to explore possibilities for the Monument Circle reconstruction project, funded by unspent Knozone Grant dollars and a National Endowment for the Arts "Our Town" grant

PROPOSAL NO. 85, 2015 - approves an additional appropriation of \$6,611,218 in the 2015 Budget of the Department of Public Works (Stormwater Fund) to fund costs necessary for the impervious surfaces calculations, CIP development and to begin stormwater capital projects
