NOTICE OF INTENT TO CONSIDER ORDINANCE PROPOSAL

Pursuant to I.C. § 36-7-4-607(e), notice is hereby given that the City-County Council intends to consider Proposal No. 105, 2015 at the regularly scheduled meeting of the Council on April 20, 2015, at 7:00p.m in the Public Assembly Room, City-County Building, 200 E. Washington Street, Indianapolis, Indiana. The ordinance proposal would amend the zoning ordinance of Marion County, Indiana to impose a moratorium on the construction of any gasoline service station, or convenience market where gasoline or other motor fuels are stored and subsequently dispensed, on all real property within Marion County that is zoned C-3, until the date when amendments to the zoning ordinances (commonly known as Indy Rezone) of Marion County, Indiana are adopted or June 1, 2016, whichever is earlier in time. The proposed amendment is on file in the office of the Council and is available for inspection during normal Council office hours.
