PROPOSAL NO. 228, 2015 - amends the Code by adding a new Sec. 451-4 regarding the reporting of lost or stolen firearms

PROPOSAL NO. 284, 2015 - approves the issuance of Economic Development Tax Increment Revenue Bonds in an amount not to exceed \$75 million to fund certain infrastructure improvements within the Consolidated Redevelopment Allocation Area commonly known as 16 Tech
