PROPOSAL NO. 412, 2015 - amends the Council Rules to reflect the reduction in the number of councillors from 29 to 25 and makes other technical corrections

PROPOSAL NO. 414, 2015 - amends the Code to delete obsolete references to township assessors and to renumber Chapter 671, regarding employment of ex-offenders, to Chapter 670
