There will be a meeting of the Public Works Committee of the City-County Council on **Thursday, December 10, 2015** at **5:30 p.m.** in **Room 260** of the City-County Building. It is anticipated that the following items may be considered by the Committee:

PROPOSAL NO. 288, 2015 - approves the issuance of Indiana Storm Water Revenue Bonds and, if necessary, one or more series of bond anticipation notes, in an aggregate principal amount not to exceed \$50 million for various stormwater projects in Marion County

PROPOSAL NO. 289, 2015 - amends the Code to revise the stormwater fee applicable to qualified residential properties

PROPOSAL NO. 290, 2015 - amends the Code by adding a new Sec. 621-129 regarding parking at Blue Indy locations

PROPOSAL NO. 311, 2015 - amends the Code to make various changes regarding parking restrictions to mirror existing parking conditions currently in place (Districts 3, 8, 9, 13, 15, 16, 19, 21 and 23)

PROPOSAL NO. 330, 2015 - amends the Code to revise the sections establishing stormwater user fees and to revise certain other related sections to repeal changes made by General Ordinance No. 43, 2014

PROPOSAL NO. 398, 2015 - authorizes parking restrictions on the north side of 66th Street, from Ferguson Street to Cornell Avenue (District 3)

PROPOSAL NO. 399, 2015 - authorizes parking restrictions along Shelby Street for the Red Line Bus Rapid Transit project (Districts 16, 19, 20, 23)

PROPOSAL NO. 400, 2015 - authorizes intersection controls at Steinmeier Drive and 72nd Place (District 4)

PROPOSAL NO. 401, 2015 - authorizes intersection controls in the Coventry Park subdivision (District 24)

PROPOSAL NO. 402, 2015 - authorizes intersection controls in the Harvard Green at Camby Village subdivision (District 22)

PROPOSAL NO. 403, 2015 - authorizes intersection controls on Coles Creek Lane and Wichita Hill Drive in the Wichita Hills at Southern Dunes subdivision (District 22)

PROPOSAL NO. 404, 2015 - authorizes intersection controls in The Groves at Camby Village subdivision (District 22)

PROPOSAL NO. 405, 2015 - authorizes intersection controls in the Arrowhead at Southern Dunes subdivision (District 22)
