PROPOSAL NO. 146, 2015 - amends the Code regarding city-county holidays

PROPOSAL NO. 169, 2015 - reappoints Janai Downs to the Equal Opportunity Advisory Board

PROPOSAL NO. 170, 2015 - appoints Greg Stowers to the Equal Opportunity Advisory Board

PROPOSAL NO. 171, 2015 - transfers \$1,099,181 from the County General fund to the Auditor's Ineligible Deduction fund in the 2015 budget of the Marion County Auditor's Office for costs related to the homestead verification process and appropriates \$2,119,000 in the Auditor's Ineligible Deduction fund to cover contractual expenses related to the homestead verification process as well as records modernization efforts

PROPOSAL NO. 172, 2015 - appropriates \$1,500,000 and transfers appropriation between characters in the 2015 Budget of the Marion County Information Services Agency, for covering the costs associated with enterprise-wide network infrastructure improvements

PROPOSAL NO. 178, 2015 - transfers a total of \$50,000 in the 2015 Budget of the Office of Finance and Management (Public Safety Income Tax Fund) to cover costs related to public safety test supplies for interview and assessment process for entry-level applicants

PROPOSAL NO. 205, 2015 - approves the Mayor's appointment of Jeffery M. Heinzmann as hearing officer to preside over the administrative adjudication of parking citations and environmental violations

PROPOSAL NO. 128, 2015 - amends Sec. 279 of the Code regarding Police Merit Board member selection and the hiring, promoting and disciplining of police officers

PROPOSAL NO. 129, 2015 - amends Sec. 252 of the Code regarding the hiring, promoting and disciplining of firefighters and changing the provision for death leave for firefighters in the non-suppression division
