PROPOSAL NO. 120, 2016 - reappoints Barbara Howard to the Alcoholic Beverage Board of Marion County

PROPOSAL NO. 146, 2016 - amends Chapters 293 and 909 of the Code regarding ethics and lobbying activity to enhance integrity, transparency and accountability with respect to city and county employment, post-employment business relationships, contracting and lobbying activities; and to strengthen the regulation of lobbyist activity and tighten city-county ethics policies

PROPOSAL NO. 112, 2016 - amends the Code to restructure the department of public safety to allow the mayor to directly oversee IMPD and IFD, to create the office of public health and safety, and to recodify the office of citizen's police complaints and the animal care and control division
