NOTICE OF INTENT TO CONSIDER ORDINANCE PROPOSAL

Pursuant to I.C. § 36-7-4-607(e), notice is hereby given that the City-County Council intends to consider Proposal No.154 upon its introduction to the Council at the regularly scheduled meeting of the Council on April 11, 2016, at 7:00p.m in the Public Assembly Room, City-County Building, 200 E. Washington Street, Indianapolis, Indiana. The ordinance proposal was approved by the Metropolitan Development Commission on March 16, 2016, and would amend portions of the "Revised Code of the Consolidated City and County" regarding the Flood Control Secondary Zoning District to adopt new flood control district maps as provided by FEMA and amend the regulations regarding development within the flood control districts, to take effect immediately.
