There will be a meeting of the Public Safety and Criminal Justice Committee of the City-County Council on **Wednesday, April 20, 2016, at 5:30 p.m. in Room 260** of the City-County Building. It is anticipated that the following items may be considered by the Committee:

PROPOSAL NO. 106, 2016 - reappoints Stacie Hurrle to the Animal Care and Control Board

Presentation on the Police Athletic League (PAL), Our Kids (OK), and Pink Boots Programs – Chris Reeder, Director of Re-Entry

PROPOSAL NO. 157, 2016 - approves an additional appropriation of \$275,000 in the 2016 Budget of the Marion County Public Defender Agency (County General Fund) to cover expenses associated with the Richmond Hill explosion case and other capital cases, offset by a reimbursement from the Indiana Public Defender Commission

PROPOSAL NO. 169, 2016 - appropriates \$50,000 in the 2016 Budget of the Department of Public Safety, Indianapolis Metropolitan Police Department (IMPD General Fund) for recruiting efforts

PROPOSAL NO. 158, 2016 - amends the Code to add a provision requiring firing ranges maintained by IMPD to be made available for use by the public

PROPOSAL NO. 144, 2016 - prohibits the operation of Unmanned Aircraft Systems at certain locations and at certain times
