PROPOSAL NO. 386, 2006 - appoints Brenda Rising-Moore to the City-County Administrative Board

PROPOSAL NO. 387, 2006 - approves the Mayor's appointment of Sherlonda Anderson as the Director of the Department of Administration and Equal Opportunity

PROPOSAL NO. 388, 2006 - approves the Mayor's appointment of Katherine E. Aeschliman as hearing officer to preside over the administrative adjudication of parking citations

PROPOSAL NO. 389, 2006 - authorizes the issuance and sale of one or more series of notes to procure funds to provide for the purchase or lease of certain equipment, vehicles and related capital items and appropriates such sum, not to exceed \$12,250,000

PROPOSAL NO. 390, 2006 - approves the issuance of limited recourse notes of the Redevelopment District for the purpose of paying the cost of redevelopment, including the construction of certain public infrastructure improvements, in the Near Eastside Redevelopment Area

PROPOSAL NO. 391, 2006 - approves the issuance of special taxing district bonds, notes or other obligations of the Redevelopment District payable from taxes on real property and certain personal property of designated taxpayers located in the Consolidated/Harding Street Redevelopment Allocation Area and from other revenues of the Metropolitan Development Commission, acting as the Redevelopment Commission, in order to fund capital improvements at the downtown canal
