There will be a meeting of the Public Safety and Criminal Justice Committee of the City-County Council on **Wednesday, January 11, 2006**, at **5:30 p.m.** in room **260**. It is anticipated that the following items may be considered by the Committee:

PROPOSAL NO. 668, 2005 - appoints Dr. Eugene White to the Marion County Community Corrections Advisory Board

PROPOSAL NO. 2, 2006 - approves an increase of \$194,748 in the 2006 Budget of the Marion Superior Court (State and Federal Grants Fund) to provide funding that benefits the Community Work Service program and the Indy Nite Lite program, both of which are provided to the juvenile court by the probation department

PROPOSAL NO. 3, 2006 - approves certain public purpose grants totaling \$500,000 from the Drug Free Community Fund

PROPOSAL NO. 4, 2006 - approves an appropriation totaling \$271,188 in the 2006 Budget of the Marion County Community Corrections (Conditional Release Fund) to pay personal services expenses and equipment lease costs associated with the pre-trial home detention program, financed by fund balance

PROPOSAL NO. 5, 2006 - approves an increase of \$14,000 in the 2006 Budget of the Department of Public Safety, Animal Care and Control Division (Consolidated County Fund), to install soundproofing banners in the animal shelter and to pay advertising costs associated with the Canine Crime Stoppers tip line program and other anti dog-fighting outreach initiatives, financed by private donations
