PROPOSAL NO. 164, 2008 - appropriates \$2,000,000 in the 2008 Budget of the Department of Metropolitan Development (Consolidated County Fund) to fund the request for proposals process in 2008 to award funding for affordable housing opportunities for low-income families, funded by Housing Trust Fund balance

PROPOSAL NO. 165, 2008 - appropriates \$200,000 in the 2008 Budget of the Department of Metropolitan Development (Federal Non-Lapsing Grants) to fund the remediation of hazardous substance contamination in the soil and ground water at the former Flowers Cleaner site in the Fall Creek Place neighborhood, financed by an Environmental Protection Agency Brownfield Cleanup Grant
