PROPOSAL NO. 66, 2008 - appoints Tammie S. Jones to the Crime Prevention Advisory Board

PROPOSAL NO. 204, 2008 - appropriates \$381,821 in the 2008 Budget of the Department of Public Safety, Fire Division (Non-Lapsing Federal Grants Fund) to purchase fire suppression turn out gear, including fire resistant coats and pants, funded by an Assistance to Firefighter Grant provided by the U.S. Department of Homeland Security

PROPOSAL NO. 205, 2008 - transfers \$9,000 in the 2008 Budget of the Marion County Forensic Services Agency (State and Federal Grants Fund) to fund a required upgrade to the Combined Offender Database Information System (CODIS) server, funded by a DNA Cooperative Agreement grant from the U.S. Department of Justice in association with the National Institute of Justice

PROPOSAL NO. 206, 2008 - appropriates \$75,200 in the 2008 Budget of the Marion County Forensic Services Agency (State and Federal Grants Fund) to fund the purchase of specific laboratory equipment, financed by a Paul Coverdell Forensic Sciences Improvement grant from the U.S. Department of Justice in association with the National Institute of Justice
