

Fee Waiver Request for Sheriff Sale Information ONLY

Thank you for your interest in receiving Marion County Sheriff Sale information, a monthly list of foreclosed properties available at auction. To request a waiver of fees for this information, your neighborhood organization, homeowner/condominium association or community development association first be registered with the city of Indianapolis.

To register or update your organization's registration, complete the enclosed 'Organization Registration Form' (attachment 1). This form, along with the waiver request (attachment 2), must be returned by fax or mail to the proper entities noted below. Make sure the information on both documents is complete and accurate to prevent delay.

You can request up to three unique user names for members of your organization for up to one year. After a year, your organization must update its records with the city of Indianapolis and submit a waiver request marking 'renewal' on the form.

Before your request is approved, it will be reviewed by the Indianapolis Department of Metropolitan Development and Marion County Sheriff's Department. The Enhanced Access Review Committee, a subcommittee of the county's Information Technology Board, will approve or deny the request at its bi-monthly meetings.

Please keep these dates in mind as the EARC meets only six times a year:

You should receive your user name and password to view Sheriff Sale lists at www.indygov.biz approximately 4-6 weeks after final approval. Please remember that the Sheriff Sale information that is provided at no charge to your organization must be used for public purposes only.

REQUEST FOR WAIVER OF SUBSCRIPTION, STATUTORY & ENHANCED ACCESS FEES



This application is to request exemption from fees associated with online access to only the Marion County Sheriff's Real Estate Mortgage Foreclosure List of homes available for monthly auction via the IndyBIZ Web portal operated by LoGO Indiana.

Exemptions will be reviewed by Department of Metropolitan Development, Marion County Sheriff's Department and the Enhanced Access Review Committee for approval or denial. If approved, the exemption would cover the LoGO Indiana annual subscription fee, enhanced access fees and any statutory fees for the online Marion County Sheriff's Department Real Estate List. A LoGO Indiana subscription account will still be required to establish user names and passwords, the user agreement can be found at <https://www.civicnet.net/subscribe.html>.

All questions listed below MUST be answered and the application submitted to LoGO Indiana at the address listed at the bottom of page 2. In addition, your group must be a registered neighborhood organization recognized by the City of Indianapolis. The 'Organization Registration Form' can be found in this packet (or online at <http://imaps.indygov.org/RegOrgs/>). Follow the directions indicated on the form and submit to the address listed. The Organization Registration form IS NOT submitted to the LoGO Indiana address.
